

## FundingPips Reward Transfer Instruction & Consent Form

Campaign Name: *Power-Up Bonus – 20% Trading Credit for FundingPips Rewards*

### 1. Reward Transfer Instruction

I, the undersigned hereby instruct FundingPips to transfer my approved reward directly to my verified Tradin live trading account indicated above.

I understand that upon execution of this transfer:

- (i) FundingPips' responsibility for the reward shall be fully discharged once the funds are credited to the designated Tradin account;
